DEFERRED MAINTENANCE “A PROMISE KEPT”

When Measure G was passed in 2002, the TUSD Board of Education, Superintendent, and staff made a promise to the community that the District would continue with its deferred maintenance program (repair and maintain school facilities on an ongoing basis) while modernization construction was underway. The District kept that promise and continued with deferred maintenance during the past two summers.

In the summer of 2006, the following deferred maintenance work was completed:

- Carpet was replaced in several rooms at Estock and Heideman elementary schools, and Foothill and Tustin high schools.

Over the past three years, approximately 470,000-square feet of roofing has been replaced and more than \$2 million has been spent on deferred maintenance projects throughout the District.

PHASE III – FOOTHILL FACILITY MASTER PLAN & CONSTRUCTION



A final draft of the Foothill High School Facility Master Plan was approved by the school board at a special meeting in August. NTD Stichler Architecture was hired and is developing the school's facility plan.

The Foothill Facility Master Plan will serve as a guide or blueprint for future development of the campus — modernization of existing facilities and site improvements.

The Board approved the first phase of the project – basic infrastructure, science building and parking lot reconfiguration. The second phase will include the swimming pool and multipurpose building, depending on future funding. District staff will continue to work with NTD in preparation for submitting infrastructure drawings to the District State Architecture's (DSA) office by mid-December, receive DSA approval in February and start modernization work in the summer of 2007.

TUSTIN HIGH SCHOOL UPDATE

The Tustin Unified School District continues to move forward on the possible relocation of Tustin High School to Tustin Legacy (former Tustin Marine Corps Air Station).

The District is working with the City of Tustin, Legacy Partners, Lennar and the State of California on the relocation project. Currently, TUSD is working with the Department of Toxic Substance Control (DTSC), which is the first phase in the site approval process.

Measure G is Tustin Unified's \$80 million bond, passed November of 2002 by 67 percent of voters, to repair and renovate the 20 oldest schools in the District.

Superintendent's Message

Dear TUSD Community Members:

During the past four years, the Tustin Unified School District has been involved in the largest repair and renovation project in the District's history. Eighteen school sites had nearly \$55 million of work approved for completion in the Measure G modernization program. The renovations focused on life safety, building integrity, and Americans with Disabilities Act (ADA) compliance.

The first phase of Measure G work was completed at 12 school sites – Arroyo, Beswick, Estock, Guin Foss, Lambert, Loma Vista, Nelson, Thorman, and Veeh elementary schools; Hewes Middle School; and Foothill and Tustin high schools.

The second phase of Measure G work has been completed at six school sites – Benson, Heideman, and Tustin

Memorial Academy elementary schools; and Columbus Tustin, Currie, and Utt middle schools. The Phase II work was similar to Phase I. The Measure G work included modifications to parking areas, playground areas, landscaping, lighting, fire hydrants, fire alarms, bathrooms, drinking fountains and other renovation projects. The cost for all six schools was approximately \$8 million (please see breakdown per school on panel otherside).

For the next phase, the District has selected an architectural firm and is in the process of an extensive modernization program at Foothill High School.

We thank you for your support and look forward to communicating in the future regarding the progress with the construction projects.
